Students presently enrolled in St. Mary's University (StMU) Student Health Insurance Plan are eligible for Continuation of Coverage underwritten by Tufts Insurance Company (TIC), and administered by Christie Student Health Plans LLC (CSHP). Christie Student Health is the brand name for the student health products and services provided by TIC and CSHP. Continuation of Coverage is only available to Insured Students who have graduated or are no longer eligible for coverage under the StMU Student Health Insurance Plan. Covered students must have been insured for at least six (6) continuous months before coverage terminated under the Prior and/or Current Plan.

Continuation of Coverage is in effect from the date coverage under StMU's Student Health Insurance Plan expires, if the completed enrollment form and applicable premium are received within 30 days of Covered Person's termination date, and continues for 90 days.

The premium must be received within 30 days after the existing coverage under the StMU Student Health Insurance Plan terminates. The total premium must be paid at the time of enrollment. There is no renewable option.
