Important Insurance Update

- SAIC has selected National Guardian Life Insurance Company insurance carrier for the 2017-2018 policy year.
- Students will be covered by Cigna's national PPO network with access to over 840,000 providers and 6,000 hospitals nationwide.
- Students will also have access to prescription benefits with the CVS Health national pharmacy network. This network includes over 64,000 retail pharmacies including Walgreens, Rite Aid and CVS.

Eligibility

The School of the Art Institute of Chicago (SAIC) requires health insurance coverage for all full-time domestic undergraduate, graduate, exchange and certificate students.

The premium for SAIC's Student Health Insurance Plan (SHIP) will automatically be charged, per semester, to each student's account. If students have insurance coverage comparable to SAIC's SHIP, a waiver may be submitted online by the published deadline(s) at saic.myahpcare.com.
