<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. <u>Preventive care</u> , Pediatric Dental, Pediatric Vision and categories with <u>copay</u> are covered before you meet your <u>deductible</u> . **Does this plan provide Minimum Essential Coverage? Yes**
