## Who can enroll?

The School of the Art Institute of Chicago (SAIC) requires health insurance coverage for all international students.

The premium for SAIC's Student Health Insurance Plan (SHIP) will automatically be charged, per semester, to each student's account. If students have insurance coverage comparable to SAIC's SHIP, a waiver may be submitted online by the published deadline(s) at [saic.myahpcare.com](http://saic.myahpcare.com).

To waive the student health insurance plan, you must complete the online waiver by the deadline. If you do not waive coverage by the deadline, the premium will be charged to your student account. No changes will be made to a student's account after the waiver deadline.

Dependent coverage is available. Payment must be paid directly to Academic HealthPlans and may not be billed to the student's account. Dependents will not automatically be re-enrolled.
