All benefits are based upon the allowable amount, which is the amount determined by BCBSOK as the maximum amount eligible for payment of benefits. A contracting dentist cannot bill for charges in excess of the allowable amount. Benefits for services provided by a non-contracting dentist will be based upon the same allowable amount. It is likely the non-contracting dentist will bill for amounts above this, resulting in higher out-of-pocket expenses.
