Are there services covered before you meet your deductible?	Yes. In- Network Preventive care , In- Network Outpatient Mental Health/Substance Use Disorder expenses, In- Network Physician's Office Visits , Prescription Drugs , and Pediatric Dental expenses are covered before you meet your deductible .
