Students presently enrolled in Clemson University (Clemson) Student Health Insurance Plan are eligible for Continuation of Coverage underwritten by Blue Cross Blue Shield of South Carolina. Continuation of Coverage is only available to Insured Students and covered Dependents who have graduated or are no longer eligible for coverage under the Clemson Student Health Insurance Plan. Covered students must have been insured for at least the previous semester before coverage terminated under the Prior and/or Current Plan.

Continuation of Coverage is in effect from the date coverage under Clemson’s Student Health Insurance Plan expires, if the completed enrollment form and applicable premium are received before the Covered Person’s termination date, and continues until the end of the period for which premium is paid.

The premium must be received before the existing coverage under the Clemson Student Health Insurance Plan terminates. The period of coverage must be specified and purchased on the next page and the total premium must be paid at the time of enrollment. There is no renewable option and no refunds are available after you have selected the coverage.
