Changes for 2025–2026

UnitedHealthcare Insurance Company will be the new insurance provider for the 2025–2026 plan year. Changes also include modifications to plan details such as deductibles, co-insurance, and other coverage elements. Please take time to review the updated benefits information to understand how these changes may affect your coverage.

Eligibility

All international students are automatically enrolled in and billed for the college-sponsored Student Health Plan (SHP), provided by UnitedHealthcare and administered by Academic Health Plans (AHP). Enrollment in this plan is mandatory.

To be eligible for coverage you must:

1. Be enrolled in a degree-granting program (not enrolled exclusively in online courses or short-term courses).
2. Pay the required premium; and
3. Attend classes for at least the first 31 days of the period for which premium has been paid.
