HOW TO WAIVE

If you have other adequate health insurance and would like to waive the Student Health Insurance Plan, you must go online to csm.myahpcare.com and complete the online waiver by the deadline dates each semester. The Annual waiver period begins 07/15/2026 and the waiver deadline is 09/02/2026. The Spring/Summer (new students) waiver period opens 12/15/2026 and the deadline to waive is 01/20/2027. The Summer (new students) waiver period opens 04/15/2027 and the deadline to waive is 05/28/2027.
