Special notes on waiving coverage

- To waive the student health insurance plan, you must complete the online waiver by the deadline.
- If you do not waive coverage by the deadline, the premium will be charged to your student account.
- No changes will be made to the student's account after the waiver deadline.

Who can voluntarily enroll?

- Dependent coverage is available. Payment must be paid directly to Academic HealthPlans and may not be billed to the student's account. Dependents will not automatically be re-enrolled. You will need to re-enroll by each semester's deadline.
