Enrollment Information

- All Domestic Undergraduate students enrolled in six (6) or more credit hours and all International Undergraduate students enrolled at UMD are required to purchase this plan, unless proof of comparable coverage is provided.
- Part-time students, non-degree-seeking students and students enrolled in certificate programs, exclusively online programs, and/or programs at the Shady Grove campus are encouraged, but not required, to have health insurance, unless the student's immigration status requires insurance.
- Students must actively attend classes for at least the first 31 days after the first day of class. Home study and/or correspondence work do not fulfill the eligibility requirements for active class attendance.
- Eligible students who enroll in this plan may also enroll their eligible dependents. Eligible dependents include the student's spouse and dependent children under age 26. their eligible dependents. Eligible dependents include the student's spouse and dependent children under age 26.

Payment Information

- Graduate students who are full-time, degree-seeking graduate students at College Park will be charged for SHIP on their UMD student account in the Fall and Spring, unless a waiver is submitted by the deadline. Students who want to be enrolled in SHIP should go to umd.myahpcare.com to activate coverage which will enable access to benefits as soon as possible. To enroll dependents, students must use the voluntary enrollment process and pay the premium by credit card and ACH.
- Graduate students eligible for voluntary enrollment may enroll in SHIP online and pay the premium by ACH or credit card. To enroll dependents, students must use the voluntary enrollment process and pay the premium by ACH or credit card.
