Student Health Insurance Plan 2023-2024

Eligibility

All medical students are required to purchase this insurance plan unless proof of comparable coverage is furnished. Students on a university approved Medical Leave are eligible to enroll on a voluntary basis for continued coverage under this plan for only the first term immediately following a university approved medical withdrawal, provided they were enrolled in this plan for the term prior to the leave.

Waiver announcements will be sent to the SOM email address and it is the student's responsibility to submit a waiver during the open waiver period.

Eligible dependents of those enrolled in the plan may participate in the plan on a voluntary basis through Academic HealthPlans. Dependent eligibility expires concurrently with that of the Insured student.

Waiver Information


School of Medicine students who have insurance that is comparable to the UNR Student Health Insurance Plan offered through a different insurance company (i.e. through an employer, spouse, parent/guardian, scholarship, etc.), and DO NOT want to take part in the UNR Student Health Insurance Plan, must complete the online waiver process by the waiver deadline and have the waiver approved to have the insurance fees removed from your student account. Students must submit an approved waiver once per academic year.

Students who are eligible and do not have insurance will automatically be enrolled in the UNR Student Health Insurance Plan each term you are eligible, (Fall and Spring/Summer), and your student account will be charged. To waive out of the insurance plan you must complete an approved online waiver through unrsom.myahpcare.com. All online waivers must be submitted by 11:59PM PST on the dates listed below. No waivers received after this time will be accepted.

Eligible dependents of those enrolled in the plan may participate in the plan on a voluntary basis.
